



# Call To 2021 National Convention



**TO:** All members of the Marine Corps League Auxiliary, INC

**SUBJECT:** Call to 2021 National Convention

In accordance with the National Bylaws and Administrative Procedures of the Marine Corps League Auxiliary and by the authority vested in me as National President, I Evelyn B. Joppa, do hereby issue the call to National Convention. This event will take place August 8 to August 13 in Springfield, Illinois.

**Purpose:** To revise/amend Bylaws and Administrative Procedures; to present resolutions; to transact business as may properly come before the Assembly; to receive reports of the National Board of Trustees and Committee Chairs, both Administrative and Standing; and to elect National Officers.

**Representation:** Please reproduce the Credential/Delegate form as needed, fill out the form completely, and deliver to the National Headquarters (PO Box 3038, Stafford, VA 22555-3038) no later than July 1, 2021. Every member is entitled to vote and does not need to have a credential form on file at National but must present a current membership card to receive convention credentials.

**Registration:** All members, delegates, alternates, officers, and guests must register to receive an admission badge/convention credentials. Badges must be visible for the National Guard when entering the meeting room for sessions.

**Meetings:** All Elected and Appointed Officers, Committee Chairs and Delegates are expected to attend all scheduled meetings and general sessions.

**Committees:** All members of Administrative and Standing Committees are expected to attend the meetings called by their respective Chairmen prior to the Convention. If you are unable to serve on the committee to which you have accepted an appointment, please notify the National President as soon as possible.

**Caucuses:** All Unit, Department, and Division caucuses, if needed, should be held prior to the final session. This will avoid taking time away from the scheduled business meeting.

# SR Vice President

Wow, here it is June already; time sure flies when you're having fun. Speaking of fun, with many states relaxing their COVID restrictions related to gatherings, it looks as if many, if not all of us, will be able to have our first Department Convention since 2019.

While virtual replaced in-person in 2020, there's no substitute for sitting next to one of your Auxiliary Sisters at a convention or meeting. With that being said, I wanted to remind everyone of "The Ten Worst Meeting Offenses":

- *Being Unprepared:* This includes officers or anyone making a report. If using technical aids, be sure they are operational. Provide an agenda and support material in advance.
- *Starting on Time:* Start the meeting at the scheduled time; if your attendance is 12 or 200 members, showing up or starting late will damage the image you are trying to project. Encourage officers and staff to have written reports to present to the membership. What have you done during the time between meetings? If you have nothing to report, it's self-explanatory. Be aware of the Meeting Hog (a person who talks just to hear herself talk).
- *Taking Part in the Meeting:* Speak up if you have something to offer. Many times, a member will not rise to address the body, but after the meeting is over then approaches the president or another officer and offers something that is beneficial.
- *Sitting Silently during the Meeting:* The extreme opposite of not taking part is the member that has nothing to offer during the meeting except idle chatter. Holding your own private meeting is not only rude, but you may also miss or make someone else miss something important being said.
- *Expressing Rude Body Language:* Avoid making facial gestures and rude comments during the meeting if you disagree with what is being said. Address the body if you so desire. Leaving the room in disagreement shows the speaker a lack of respect. It is the duty of the president to manage those being disrespectful in a tactful way, and never put a member down by trying to humiliate her.
- *Sidebar conversations are a NO-NO:* Sidebar conversations are possibly the rudest thing that can happen during the meeting. This should be stopped immediately and refocus on the subject at hand.
- *Arguing or putting others down:* Disagreements are healthy and fine, but never get into personal attacks. Don't make others look bad for the sake of making you look good! Never be condescending or avoid the opinions of the membership. Always be professional in your choice to disagree.
- *Silencing Cell Phones:* Remember to silence your cell phone or put it on vibrate prior to the meeting being called to order; no one wants to hear your ring tone.
- *Chewing Gum or Eating:* No one wants to hear gum chewing during a meeting. Eating during the meeting is discouraged. Water or another non-alcoholic beverage is permissible.
- *Shutting Down the Meeting:* If a meeting runs too long, you may have some disgruntled members. If important business needs to be settled then and there, ask for a motion to extend the meeting. This shows the membership that you care about them and are trying to be as expeditious as possible.

We may all be guilty of one or more of these transgressions over the years, but do strive to have an effective, positive meeting atmosphere. I wish everyone a productive Department Convention.

*Please refer to Section 640 of our National Bylaws:*

*(A) "... In all cases, the National Junior Vice President shall endeavor to assign the applicant to a Department and Unit of the applicant's choosing..."*

*(B) A member in good standing may, with good cause, become a Member-at-Large by requesting a transfer from her Unit with the understanding that she attempts to join a Unit of her choice.*

*(C) Regular members, Life or those who pay annually, belonging to a defunct Unit may become Members-at-Large. Those who are not regular Life Members must pay dues annually to National Headquarters.*

Ladies, all of your Division Vice Presidents, Department Presidents and Unit Presidents endeavor to help you reconnect to a Unit in your area, outside of your area or perhaps you would like to create a new Unit. Additionally, I suggest the aforementioned leaders seek out the MAL's in their areas and I am available to assist as needed. WE NEED YOU to help us bring them back into regular Units.

Some members became MAL's when their Unit closed, or when they moved to a new region and did not know if there was a Unit near them. Again, it is our inherent duty to
