Call To 2021 National Convention



TO: All members of the Marine Corps League Auxiliary, INC From: Evelyn B. Joppa, National President SUBJECT: Call to 2021 National Convention

In accordance with the National Bylaws and Administrative Procedures of the Marine Corps League Auxiliary and by the authority vested in me as National President, I Evelyn B. Joppa, do hereby issue the call to National Convention. This event will take place August 8 to August 13 in Springfield, Illinois.

Purpose: To revise/amend Bylaws and Administrative Procedures; to present resolutions; to transact business as may properly come before the Assembly; to receive reports of the National Board of Trustees and Committee Chairs, both Administrative and Standing; and to elect National Officers.

Representation: Please reproduce the Credential/Delegate form as needed, fill out the form completely, and deliver to the National Headquarters (PO Box 3038, Stafford, VA 22555-3038) no later than July 1, 2021. Every member is entitled to vote and does not need to have a credential form on file at National but must present a current membership card to receive convention credentials.

Registration: All members, delegates, alternates, officers, and guests must register to receive an admission badge/convention credentials. Badges must be visible for the National Guard when entering the meeting room for sessions.

Meetings: All Elected and Appointed Officers, Committee Chairs and Delegates are expected to attend all scheduled meetings and general sessions.

Committees: All members of Administrative and Standing Committees are expected to attend the meetings called by their respective Chairmen prior to the Convention. If you are unable to serve on the committee to which you have accepted an appointment, please notify the National President as soon as possible.

Caucuses: All Unit, Department, and Division caucuses, if needed, should be held prior to the final session. This will avoid taking time away from the scheduled business meeting.

Many years ago a PNP/PDP, good friend and mentor gave me a folder and told me I might find some helpful items inside for President's Council topics when I became National Senior Vice President. Well, the folder has proven to be a world of knowledge and ideas, not only for President's Council but for newsletter articles. Since I was not sure exactly what I was going to write about this month, I dug out my trusty folder and began paging through the contents. When I came to the page regarding Duties of Officers, a light bulb went off, resulting in what I hope will give you some ideas for your **"Transition of Position".**

We all know that when we leave our elected or appointed position we are to turn over the information relating to that position to our successor. Handing over the file(s) and giving the incoming officer an explanation of what you are giving them and a quick "this-is-what-the-position entails," in my opinion, is only half helping them become successful. Therefore, I am suggesting that, if you do not already have this process in place, you consider making the following a part of your Unit or Department Officer files:

Develop a Helpful Hints binder or folder to be passed along with the files at the end of your term of office. Included could be an outline of what is to be done on a monthy basis, a current membership listing with contact information, a detailed explanation on how to complete a transmittal and cover sheet (with a sample of each). If you keep your membership records in a certain way an example would be helpful, along with prayer suggestions for draping the charter, how to do a roll call of officers, etc. (You get the idea.)

Again, for some positions a folder will suffice rather than a binder. This way the incoming officers will have something to refer to when they have a question. We all need to remember we were new to the position at one time and had questions. Even though a member may attend all of the meetings, that doesn't mean they know how to call roll or set up the room for the meeting. The binder/folder should be updated prior to passing it along, and adding personal comments is always helpful. This binder or folder is in no way meant to replace personal one-on-one communication on how to fulfill the position; it is to used solely as a guide. Remember, the incoming officer may not do everything the same way you did, but we all have our own style and way of doing things. Believe me when I tell you that the binder passed onto me by my predecessor in my positions as National Judge Advocate, Junior Vice and now Senior Vice has proven to be invaluable.

It is important to realize that when you do not do as you promised it can create problems for the next person in that position and your unit, in general. Keep in mind that we should help each other grow in the Auxiliary and this is but one small way that we can help. When you hold a leadership position, you may want to add to the turnover file anything new that you find to be particularly helpful or create a turnover file if none exists.

Another way of helping each other is to have open discussions in Unit meetings. Have the important dialogue about the Bylaws and Administrative

Procedure changes that were provided in last month's newsletter. Equally important, all of our members should have an opportunity to talk about the issues that were presented. Subsequently, even if the
